- B. IIPS, Established in 2008 by Prabodhan Shikshan Prasarak Sanstha, Ambav, Tal Sangmeshwar, is affiliated to Mumbai University and have obtained 'B' grade in the first cycle of National Assessment and Accreditation Council (NAAC) evaluation conducted in Oct. 2017.
- C. ASPCD and IIPS desires to work in collaboration with each other for scientific research and educational activities on terms and conditions set out below.

NOW THIS AGREEMENT WITNESSETH AND IT IS AGREED BY AND BETWEEN THE PARTIES AS UNDER:

1. Purpose:

The goal of this cooperation is to foster collaboration and to facilitate advancement of knowledge on the basis of reciprocity, best efforts, mutual benefits and frequent interactions. ASPCD and IIPS agree to explore the possibility of engaging in the following modes of collaboration:

- 2) Conduction of extensive research in the field of Pharmacognosy, Medicinal Botany, Ethno Botany, Pharmacology, Pharmaceutics etc.

- 4) **ASPCD** and **IIPS** agree to jointly identify and pursue opportunities for formulation and submission of new research project proposals and or training programmes from funding agencies. The terms and conditions of such joint research project would be worked out between the concerned investigator and the funding agency.
- 5) Joint proposal or engagement in research or training programmes sponsored by funding agencies extending invitations to each other's faculty to participate therein.
- 6) Organization of seminars, conferences, workshops and short-term continuing education programmes on topics of mutual interests, while extending invitations to each other's faculty to participate therein.
- 7) Exchange on a reciprocal basis of students at graduate level for limited period of time for purposes of education and/or research.
- 8) Exchange of faculty from **ASPCD** and **IIPS** for purpose of guest lectures and/or as a resource person.
- 9) **ASPCD** and **IIPS** agree to respect each other's right to intellectual property. All background intellectual property used in connection with this MOU shall remain the property of the party that introduces it. No license is granted to any party to use another party's background intellectual property unless specifically agreed to in writing. Further, the intellectual property rights that arises as a result of any collaborative research or joint activity under this MOU would be subject to separate written agreement(s) on the ownership and management of such intellectual property and each party agrees to respect the ownership of intellectual property of the other

parties in all dealings, consistent with officially laid down intellectual property rights policies of the partner institution.

10) Provision of consultancy on the campus development of both **ASPCD** and **IIPS**.

11) No party of this memorandum shall use the name, logo or any other designation of any of the other parties without prior written consent.

12) The terms of any financial management will be subject to separate agreement(s) made on a case-by-case basis; such further agreements will include the names of those persons responsible for managing the implementation etc. of collaborative activity.

2. Term of the Agreement:

The term of this MOU is for 5 (Five) years commencing from the date it is signed by representative of the two institutions. The parties may decide to further extend the term of this MOU by mutual consent on terms and conditions as may be agreed between them.

3. Further Agreements:

This MOU will be reviewed after three years; the terms of this MOU may be amended by mutual written agreement prior to the date of review. Any extension to this MOU will be formally agreed in writing by the parties.

4. Amendment/Termination of MOU

- i. Any amendment to the terms of this agreement can only be made by mutual consent of the parties.

- ii. Either institution may terminate the MOU by giving written notice to the other institution six months in advance. Once terminated, neither ASPCD nor IIPS will be responsible for any losses, financial or otherwise, which the other institution may suffer. However ASPCD and IIPS will ensure that all activities in progress are allowed to complete successfully.

AND WHEREAS NKC, established in 1983, is an autonomous college, affiliated to Mumbai University, and has been reaccredited with an 'A' grade by NAAC (3rd cycle) and is ISO 9001:2015 certified.

AND WHEREAS ASPCD and NKC (who for this MoU are hereinafter individually referred to as 'PARTY' and collectively referred to as the 'PARTIES') desire to work in collaboration with each other for academic exchange, scientific research, and collaboration on terms and conditions set out in this MoU.

AND WHEREAS it has been considered expedient to agree in writing to participate jointly in undertaking students- and research projects as per the expertise and logistics available with the PARTIES.



THIS AGREEMENT WITNESSETH AND IT IS AGREED BY AND BETWEEN THE PARTIES AS UNDER:

Article 1: Objective and Principles:-

1. The objective of this MOU is to foster collaboration and to facilitate the advancement of knowledge based on reciprocity, best efforts, mutual benefits, and frequent interactions.
2. This MOU intends to set out the general principles of cooperation in the field of academic exchange (faculty and student), collaboration, research, sharing of resources and infrastructure, etc. according to which the parties may jointly conduct the activities in the area.
3. This MOU will be carried out within the framework of the respective laws and regulations of the institutions and is intended to create legally binding rights or obligations.

Article 2. Areas of Cooperation

1. Geography
2. Geospatial Technology
3. Urban Planning
4. Area Studies
5. Smart Geographies

Article 3. Forms of Cooperation

1. Faculty Exchange
2. Add-on/skill-based courses
3. Seminars, workshops, and lectures on topics of mutual interest and relevance
4. Public outreach programs
5. Fieldwork
6. Students' Exchange

Article 4. Exchange of Information and Research Samples

1. The term "information" includes scientific or technical data, results and/or methods of investigation, and other information intended to be exchanged or arising under the objectives identified under Article 1. The PARTIES shall take all measures to protect the secrecy of and avoid disclosure and unauthorized use of the information which is confidential and outside the public domain.
2. Samples exchanged between the PARTIES shall not be transferred to any third party for research and commercial purposes and that the unutilized portions of such samples must be sent back to the concerned coordinators identified under Article 6.1.



Article 5. Publications and Intellectual Property Rights

1. Any research publications and intellectual property rights arising out of the students and joint research projects shall be jointly published and, when patented, will be jointly and equally owned by ASPCD and NKC.
2. The procedural formalities for securing and maintaining the intellectual property rights shall be the responsibility of both ASPCD/NKC and the expenditure incurred thereof shall be borne jointly and equally by both.
